

Doniphan County Health Dept./Home Health Isolation and Quarantine Guidance for Students and Staff for COVID-19

When a Student or Employee Should Stay Home from School



- Students and employees exhibiting symptoms of COVID-19 without other obvious explanations, are prohibited
 from coming to school or childcare. STAY HOME IF YOU ARE SICK. If a student or employee comes to school with
 COVID-19 symptoms, they will be sent home immediately. School district employees and parents should be familiar
 with current COVID-19 symptoms:
 - Fever (100.0 degrees F or higher)
 - Chills, Rigors (shivering/shaking)
 - Muscle or body aches
 - Fatigue
 - Headache
 - Sore Throat
 - · Cough, Shortness of breath, difficulty breathing
 - New loss of taste or smell
 - Diarrhea, abdominal pain, or vomiting



- A student or employee has tested positive for COVID-19.
 - If a student or employee has tested positive for COVID-19 the parent must notify the school of the positive result. The school should notify the Doniphan County Health Dept./Home Health of the positive result.
 - COVID-19 confirmed positive cases must be excluded from school and isolate at home for 10 calendar days since symptoms first appeared and remain fever-free for 72 hours without the use of fever reducing medication, whichever period is longer.
- 3. A student or employee who has been tested for COVID-19 and is awaiting test results is considered a presumptive positive case and MUST STAY HOME and isolate until results come back. If results are negative, the person in question may return to school if they are symptom/fever-free. (Insert your school policy if different from highlighted area)



- Other students and employees in the household of a positive case or who has been exposed to a known case of COVID-19.
 - If a student or employee is excluded from school because of a positive COVID-19 test, other students, children, and employees living in the same household are considered close contacts and will be excluded from school for a mandatory 14-day quarantine period, which begins after their last exposure to the confirmed/positive case.
 - If the household contact continues to live in the same household as the positive case while the positive case is in isolation, the 14-day quarantine period for the household contact(s) begins, once the case is released from isolation by the Doniphan Co. Health Dept./Home Health. That means the household contact may need to remain home longer than the initial case.
 - If a student or employee has otherwise been identified by the Doniphan Co. Health Dept./Home Health or the school nurse, as a close contact (within 6ft for longer than 10 minutes), they must be excluded from school/childcare/work for a mandatory 14 day quarantine period.



. Travel- Related quarantine

 A student or employee has recently traveled from a location on the Kansas Department of Health and Environment (KDHE) travel-related quarantine list, they are subject to a mandatory 14-day quarantine starting from the day after they return to Kansas. Return to school after exclusion



- 1. **Untested, with symptoms**: Person who have not received a test proving or disproving the presence of COVID-19, but experience symptoms, may return if the following conditions are met:
 - 10 calendar days have passed since symptoms first appeared.
 - Fever free for 72 hours without the use of fever reducing medication, whichever is longer.
- 2. **Positive result**: Positive cases may return if the following conditions are met:
 - 10 calendar days have passed since symptoms first appeared, fever free for 72 hours without the use of fever reducing medication, whichever is longer.
 - If asymptomatic (no symptoms), cases may return if 10 calendar days have passed since the date the sample was collected and no symptoms have developed.



3. Negative Result:

- People who are identified as close contacts of a COVID-19 case or have traveled from a location on the KDHE travel-related quarantine list must be quarantined for 14 days. A negative test result within the 14-day quarantine period does not affect the quarantine period and the person must finish their 14-day quarantine.
- People who have not been identified as a close contact to a COVID-19 case and have not traveled from a location on the KDHE travel-related quarantine list may return to school or work.



- 4. Tested and awaiting results: Persons who are suspected of having COVID-19 disease and are awaiting *test* results should be isolated at home until test results are received.
 - Once results come back, follow the corresponding instructions above for a positive result.

COVID-19 Case Definitions

Asymptomatic: presenting no symptoms of disease.

Confirmed positive case: A certified laboratory approved positive COVID-19 test in an individual.

Contact tracing: identifying and monitoring people who may have come into contact with an infectious person.

COVID-19: COVID-19 stands for novel coronavirus disease 2019, which refers to the year of its initial detection. COVID-19 is the illness related to the current pandemic; the illness is caused by the virus SARS-CoV-2 {severe acute respiratory syndrome coronavirus 2).

Close contact: an individual that has come in contact for more than 10 minutes and within 6 feet of a person that is confirmed to have COVID-19.

Exposure: When you are within six feet of someone who is showing symptoms of COVID-19, for at least 10 minutes.

Isolation: Isolation involves separating people who are sick and have tested positive for COVID-19 from people who are not sick.

Incubation period: The amount of time it takes for an infected person to start showing symptoms of illness after exposure. In the case of COVID-19, the incubation period is thought to be between 2-14 days.

Presumptive positive case: an individual who has tested positive for COVID-19 by a local public health lab, but whose results are awaiting confirmation from the CDC.

PUI: person under investigation, or a PUI, is an individual who is suspected of potentially having COVID-19.

Social distancing: the act of remaining physically apart to reduce transmission of COVID-19. Social distancing can include a move to remote work, the cancellation of events and remaining at least six feet away from other individuals.

Symptomatic: showing symptoms of COVID-19.

Quarantine: Quarantine refers to restricting the movement of people who were exposed to the virus but are not sick, to see if they become sick.
